

## **Euston Area Plan Update Proposed Submission Draft 2026**

### **Statement of Fact and Statement of Representations Procedure**

This notice is provided in accordance with Regulation 19 of the Town and Country Planning (Local Development) (England) (Amendment) Regulations 2012.

**The Euston Area Plan Update - Proposed Submission Draft** is the title of the document which the Council intends to submit to the Secretary of State. The Plan sets out the Council's vision for the development of Euston until 2051 and planning policies and site allocations to help achieve this. It will form the basis for Councils decisions on planning applications and set the framework for future development in the Euston area.

### **Representation period:**

Originally, representations could be made over a six-week consultation period from Friday 9 January 2026 to Sunday 22 February 2026. This was extended on Tuesday 20 January to Tuesday 3 March.

When making representations on the Euston Area Plan Update Proposed Submission Draft the following questions should be considered:

- **Is the plan legally compliant?** Does the plan comply with the relevant legislation and regulations in the way it has been prepared, and in its content?

- **Does the plan comply with the ‘Duty to Cooperate’?** Has the local planning authority engaged constructively, actively and on an ongoing basis with the plan?
- **Is the plan ‘sound’?** Has the plan been ‘positively prepared’? Is it robustly justified and evidence-led? Will it be effective in what it sets out to achieve? Is it consistent with regional and national planning policy?
